

- Do you have old location codes for collections you no longer have?
- Do you have location codes that say DO NOT USE, OLD CODE, or NOT IN USE?
- Do you have item types that are not attached to any items?
- Are you collecting data from patrons that you don't report anywhere?
- Do you have processes that are burdensome and unnecessary for staff?
